

ORDINANCE NO. 18

AN ORDINANCE PROVIDING REQUIRED PROCEDURES FOR
ONSITE WASTEWATER TREATMENT AND DISPOSAL SYSTEMS
FOR DES MOINES COUNTY

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF DES MOINES COUNTY,
IOWA:

Section 1. ENACTMENT. There is hereby adopted by reference 900 Iowa Administrative Code, Chapter 69, "ONSITE WASTEWATER TREATMENT AND DISPOSAL SYSTEMS". (Copies of said Code are available in the Office of the Des Moines County Board of Health and the Des Moines County Auditor.)

Section 2. DEFINITION. As used in the provisions adopted by reference herein, the term local board of health should mean the Des Moines County Board of Health.

Section 3. PERMIT FEES. A person desiring a permit required by the provisions adopted by reference herein, shall pay such fees as are established by the Des Moines County Board of Health and are on file in the Office of the Des Moines County Health Center.

Section 4. VIOLATIONS. It shall be unlawful for any person to violate any of the provisions adopted by reference herein. Any violation is hereby declared to be a simple misdemeanor and shall be punished by a fine not exceeding One Hundred Dollars (\$100.00) or by imprisonment not exceeding Thirty (30) days. Each day any violation of the provisions hereby adopted by reference shall constitute a separate and distinct offense.

Section 5. REPEALER. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 6. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 7. EFFECTIVE DATE. This Ordinance shall be in effect after its final passage, approval and publication as provided by law.
